

# DoDDS VOUCHER FOR THE ACT ASSESSMENT SURCHARGE

October 2005 through June 2006

This ACT voucher covers ONLY the \$18.00 surcharge for testing outside the 50 United States. The following procedures apply:

- Only students who attend Department of Defense Education Activity (DoDEA) Schools in DoDDS-Europe, DoDDS-Pacific, and DoDEA DDESS schools located on Guam and Puerto Rico are eligible. W. T. Sampson High School, Cuba, is also eligible for the DoDDS voucher.
- Vouchers may NOT be used to pay the basic test fee (\$29.00), additional college choices or additional score reports requested later.
- Students must submit a voucher each time they test.
- No refunds can be made to students who have already paid the surcharge fee, even though they would have been eligible for a voucher.

Payment of all testing fees must be forwarded to ACT with the answer folders being returned for scoring. Payment must be made in U.S. dollars in the form of a personal or cashier's check, or money order drawn on a U.S. bank in U.S. dollars and payable to ACT. Cash will not be accepted. Payment must be for the full amount due. Partial payments will not be accepted, and answer folders will not be scored if partial payments are received.

The \$29.00 basic fee includes the first four college codes entered on the folder. The additional fee for 5<sup>th</sup> and 6<sup>th</sup> code is \$7.00 each. The surcharge for testing outside the 50 United States, covered by this voucher, is \$18.00.
