PERFORMANCE WORK STATEMENT (PWS) DEPARTMENT OF DEFENSE EDUCATION ACTIVITY (DoDEA) EDUCATION DIRECTORATE PREK - 5 MATHEMATICS PROGRAM

I. BACKGROUND AND PURPOSE

The Department of Defense Education Activity (DoDEA) serves the educational needs of the dependents of the military and civilian employees stationed abroad and in the continental United States through its Department of Defense Dependents Schools (DoDDS) and the Domestic Dependents Elementary and Secondary Schools (DDESS). DoDEA schools enroll approximately 63,000 total students annually in the pre-kindergarten (PreK) through grade five curricula. This school system offers a typical American education and uses materials and equipment comparable to other stateside schools.

II. CONTRACT SCOPE AND OBJECTIVES

DoDEA requires a curriculum for teaching pre-kindergarten mathematics and kindergarten (K) through grade five mathematics curricula which supports the National Council of Teachers of Mathematics' (NCTM) *Principles and Standards for School Mathematics (PSSM)*. DoDEA also requires support through professional development that shall effectively help teachers implement the newly adopted curriculum materials.

The contractor shall provide published copyrighted instructional materials, software and services for the pre-kindergarten mathematics and kindergarten through grade five mathematics curricula adopted by DoDEA. 6. Multi-media materials integral to the course (i.e. Technology Resources for graphing calculators, software, etc., DVDs, CD-ROMS, VHS tapes, on-line digital).

Software Maintenance and Upgrades

Licenses for on-line digital mode(s) and software shall include maintenance support that shall be renewable for the four years subsequent to the base period of performance. Maintenance is defined as automatic distribution of software upgrades and revisions that can be accomplished using Internet, email, or CD-ROM/DVD media. Software and upgrades for subsequent years shall remain compatible with DoDEA's technical systems.

Technical Hotline Support

The contractor shall provide technical "hotline" support to include all of the following: telephone, the Internet, and email or listserv. This support shall be available to a minimum of 15 users at any given time from DoDEA Headquarters staff, District support staff in Europe, the Pacific, and DoDEA stateside schools. English speaking technical support shall be provided by on-line and call-in mode on a 24 hour (1 day), seven days a week basis, with a 24 hour response time (1 day).

Replacement and Replenishment

Estimated annual requirements for replacement and replenishment beyond the initial program year are approximately 10% of the base period quantities described above. However, in the case of consumable student or teacher materials, the replacement of components is anticipated at 100% replacement each year. These estimates for the base and option periods are for planning purposes only, and do not represent a commitment on the part of the Government that such quantities shall be ordered.

The contractor shall make all materials available throughout the duration of the curriculum adoption period and assure that the copyright dates of these materials remain unchanged for the entire contract period. The contractor shall make available to the DoDEA during the course of this contract separately priced component elements of the various materials and packages described above. - (4) All materials shall be free of racial, color, national origin, age, disabling conditions, sexual, religious, and ethnic bias, and shall present a balanced coverage of multi-cultural contributions, where appropriate.
- (5) **All materials shall have the Lexile level explicitly identified for each grade level pre-kindergarten through grade five.**

Instructional Materials

The contractor shall provide for the delivery of nineteen complete sets (1 set per district office and 1 set to the Contracting Officer's Representative (COR) at DoDEA HQ) of course materials to DoDEA. Delivery shall be made to each district/area mathematics liaison and instructional systems specialist, and the DoDEA Headquarters Mathematics Coordinator, no later than 60 days after the date of contract award. Two copies of any software purchased will be delivered to the area IT chiefs immediately after award. The Contracting Officer's Representative (COR) shall provide the contractor with the names and addresses of all the liaisons and instructional systems specialists.

Correlations: No later than 30 days after receipt of the new new DoDEA's Mathematics standards (<http://www.odedodea.edu/instruction/curriculum/math/stands.htm>), the contractor shall deliver correlation documents identifying the relationship of its materials to the new DoDEA's Mathematics standards (<http://www.odedodea.edu/instruction/curriculum/math/stands.htm>). The contractor shall provide these correlation documents to the DoDEA Headquarters Mathematics Coordinator, mathematics liaisons, and instructional systems specialists at each of the districts and areas listed on the DoDEA website: <http://www.odedodea.edu/data/allsites.cfm> (CTL + click on link).

Curriculum Guides: No later than 150 days after the date of contract award, the contractor shall deliver a standards-based curriculum guide for each grade level which identifies the relationship of its materials to the big ideas or essential focus identified in grades K – 5, appropriate assessment options (i.e. performance task, embedded assessments, etc.), technology related activities, other resources (i.e. websites, extra practice, etc.), trades books connected to the teaching and enrichment of the big idea, and explicit mathematical connections to the big ideas or essential focus. The contractor shall provide these correlation documents to the DoDEA Headquarters Mathematics Coordinator, mathematics liaisons, and instructional systems specialists at each of the districts and areas listed on the DoDEA website: <http://www.odedodea.edu/data/allsites.cfm> for review. After review, each grade level teacher shall receive an appropriate grade level curriculum guide.

Post-Award Conference

No later than 30 days after the date of contract award, the contractor shall participate in a Post-Award Conference with DoDEA officials to coordinate details associated with:

- Professional development planning and training;
- Delivery of core instructional materials for the course in the quantities ordered for each school.
- Preparation and submission of correlation documents

Reading Lexile Levels

No later than 30 days after the date of contract award, the contractor shall provide Fountas/Pinnell (grade 5), Lexile (grade K-5), and DRA (grade K-5) leveling with technical proposal (materials) for evaluation. A correlation Fountas/Pinnell, Lexile, and DRA leveling document may be submitted in lieu of the Fountas/Pinnell (grade 5), Lexile (grade K-5), and DRA (grade K-5) leveling to support the leveling requirement.

Professional Development Plan

Professional Development Plan: The contractor, in collaboration with the COR at DoDEA HQ, shall identify a team of facilitators with in-depth knowledge of NCTM's *Principles and Standards for School Mathematics* and new DoDEA's Mathematics standards; advanced academic and teaching credentials; knowledge of curriculum, instruction, assessment, and mathematics content relative to early childhood and intermediate grades extensive experience in providing trainer-of-trainers professional development, and delivering a variety of teaching strategies and technology into the learning environment. The facilitators shall conduct training-of-trainers, implementation training, and follow-up training of district/area mathematics liaisons, instructional system specialists and preK-5 teachers. The purpose of this training is to provide district/area mathematics liaisons, instructional systems specialists, and teachers with the knowledge and skills in using materials to directly support new DoDEA Mathematics standards and Best Practices as outlined in the DoDEA's Quality Indicator Map (QIM).

Scope and content of the Trainer-of-Trainer training and teacher Professional Development Plan shall include the following components:

- Translate new DoDEA Mathematics standards' (<http://www.odedodea.edu/instruction/curriculum/math/stands.htm>) statements into lesson objectives and unit design answering the following questions competently:
 - What do I want students to know and be able to do?
 - What knowledge/skills do students need to have prior to instruction?
 - How will I measure if the students have met the new DoDEA Mathematics standards?
 - What instructional techniques, activities, and materials will help all students to meet the new DoDEA Mathematics standards?
 - How will I examine student work to provide feedback and document student progress toward "Achievement of the Standard"?
- Apply DoDEA Quality Indicator Map best practices for curriculum, instruction, and environment to develop a unit of instruction that demonstrates the following:
 - C-1. Standards provide the foundation for the design, content, and delivery of instruction.
 - C-2. The teacher possesses content knowledge, an understanding of its relation to standards, and a facility in adapting content to allow all students access to standards.
 - C-4. Approved and appropriate materials correlated to standards are used for instruction.
 - I-2. Students are meaningfully engaged throughout the learning process.
 - I-4. Varied questioning strategies are used to support student learning.
 - I-6. Varied teaching strategies are used to support inquiry, higher order thinking, and problem solving.
 - I-7. Technology is meaningfully integrated throughout instruction to support student achievement of the standards.
 - E-1. The teacher promotes a safe and flexible physical environment, meeting the needs of diverse learners.
- Design essential performance tasks, aligned to the new DoDEA Mathematics standards that engages students; simulates a real world context; inspires curiosity; and provokes critical and creative thinking.
- Provide task-analyses that delineate precisely what a student should know and be able to do as prerequisites for achieving the concepts and skills of a performance task.
- Plan conceptual development of ideas utilizing adopted text and other resources that will enable students to achieve the performance tasks.

- Incorporate multiple assessment strategies, in addition to performance tasks.

Training of district/area liaisons and instructional system specialists shall include trainer-of-trainer standards-based modules and tools for delivery such as outlines, scripts, agendas, on-line courses, transparencies, support materials, and videos for their use during training. Throughout the life of this contract, the contractor shall provide facilitators for consultations (e.g., VTC, video, telephone, etc.), with district/area liaisons and instructional systems specialist personnel as requested. In addition, follow-up modules may be requested to provide more intensive teacher assistance and instructional models. These modules should demonstrate model lessons and best practices appropriate for the grade level.

In addition to in-depth training of trainers professional development for district/area mathematics liaisons and instructional systems specialists using a train-the-trainer model, the contractor shall also be responsible for providing similar professional development training and support for the number of teachers identified in Section III. The Professional Development Plan encompassing these various elements shall be finalized and delivered to the COR not later than 60 days after the date of contract award.

Pre-Implementation Professional Development and Support

Pre-Implementation development and support shall consist of learning prior to the actual use of instructional materials in the classroom. During Pre-Implementation training, the contractor's facilitators shall provide separate sessions of professional development training and support to mathematics liaisons/instructional systems specialists and to teachers. This training shall address the organization and content of adopted curriculum materials and how they should be used in the classroom. To facilitate this effort, the contractor shall prepare a hard copy brochures and/or video/CD ROMs providing an overview of its adopted materials demonstrating classroom lessons and best practices for each grade level. During the course of preparing the brochure and/or video/CD ROM, the contractor shall confer with DoDEA officials; present to them a preview of it; and incorporate any recommended changes DoDEA may have prior to its presentation during the course of Pre-Implementation training. The contractor shall complete Pre-Implementation Development and Support training to district/area mathematics liaisons and instructional systems specialists no later than 90 days after the date of contract award. The contractor shall complete Pre-Implementation Development and Support training for DoDEA's PreK – 5 teachers no later than May 2006.

Implementation Development and Support

Implementation development shall involve contractor travel to conduct training in districts/areas to include Europe, Pacific, and the continental United States. The contractor's facilitators shall do initial training in each district/area no later than 8 months after the date of award of Option Year 1. During each site visit, facilitators shall coordinate system wide training with the COR, and on an as needed basis, confer with school personnel, both individually and collectively, and district personnel, as appropriate; make classroom visitations for follow-up input; and present demonstration lessons. Oversight and coordination for agendas and schedules shall be defined in the Professional Development Plan by the COR. Agendas shall be developed and visit schedules formulated on a school-by-school basis in coordination with district/area mathematics liaisons and instructional systems specialists.

On-site Consultation/Maintenance Training

After the Base Year, and throughout the remainder of the life of the contract, the contractor's facilitators shall be available for on-site consultations with district/area mathematics liaisons and

instructional systems specialists as needed. All agendas shall be developed and visit schedules formulated on a school-by-school basis in coordination with district/area mathematics liaisons and instructional systems specialists. The exact dates for on-site consultations/ maintenance training shall be determined after the exercise of each Option Year under this contract.

If transportation charges are stated separately on the invoice, the Contractor shall retain related paid freight bills or other transportation billings paid separately for a period of 3 years and shall furnish the bills to the Government upon request.

(3) If this contract, order, or blanket purchase agreement requires the preparation of a receiving report, the Contractor shall prepare the receiving report on the prescribed form or, alternatively, shall include the following information on the invoice, in addition to that required in paragraph (c) (1) of this clause:
