BASIC NUMBERING SYSTEM FOR DoDEA ISSUANCES

1. **DoD Authority Policy.** In the majority of cases, the numbering of a DoDEA Issuance takes its number from the DoD Directive or DoD Instruction that gives DoDEA the authority to write policy.

EXAMPLE: DoD Instruction 6055.01 “DoD Safety and Occupational and Health Program” provides the authority under which DoDEA’s policy for DoDEA Safety Program is written. Therefore the number is DoDEA AI 6055.01.

Note: If additional DoDEA Issuances are taking authority from that same “6055” than the numbers after decimal will be sequentially given.

2. **No DoD Authority Policy.** If there is no DoD Directive or DoD Instruction that gives DoDEA the authority to write a particular issuance, than the basic number is in Arabic numerals and consists of a 4-digit number representing a major subject group and its subgroup, followed by a decimal point and a 2-digit sequential number of the subgroup. For the purpose of DoDEA, the major groupings are attached.

Note: If a new category or series needs to be created because the regulation falls outside of the existing numbering system, please contact OPLP for guidance.

3. **DoDEA Manuals.** DoDEA Manuals are assigned the same number series as the DoDEA Regulation or DoDEA Administrative Instructions. For DoDEA Manuals exceeding more than one volume (maximum of 100 pages in each volume), each volume retains the same manual number with the addition of a dash and volume number in Arabic numerals at the end.

EXAMPLE: If a manual is written on Safety and Occupational Health Program, it would be DoDEA Manual 6055.01. If there are two volumes it would be the following:

DoDEA Manual 6055.01, Volume 1. (Abbreviated as DoDEA M 6055.01-V1.)

DoDEA Manual 6055.01, Volume 2. (Abbreviated as DoDEA M 6055.01-V2.)

4. **DoDEA Procedural Guides.** DoDEA Procedural Guides use the same numbering systems as the other Issuance except at the end -XX is added. The numbering is sequential.

EXAMPLE: DoDEA Procedural Guide 6055.01-01 (if first one) (Abbreviated DoDEA PG 6051.01-01)

5. Please note that the box and bold underline is the DoD category description and not a DoDEA Division. Colored boxes indicate where the general DoDEA division's numbers are located (but not owned).
