SUBJECT: CONUS School Year (SY) 2018/2019 Tuition Rates (Includes: Guam and Puerto Rico)

The tuition rates per the attached chart applies to Federally Connected students attending the DoDEA Americas schools, including Puerto Rico and Guam during SY 2018/2019. It is the DoDEA policy to collect payment within 30 days from the tuition invoice date for a dependent who meets the enrollment criteria as a tuition paying student. Tuition is considered a debt to the Government; therefore, failure to pay tuition in a timely manner can result in the inability to enroll dependents at the beginning of the SY, or subsequent disenrollment during the SY. The published rates include a small **non-refundable Treasury Fee**. The Treasury Fee and the tuition rates are computed using the full cost recovery methodology in compliance with Government Accountability Office (GAO) guidelines.

Federally connected tuition payments will be billed in **two partial payments**:

1. First payment with FY-18 funds will cover part of the First School Quarter:
  - a. August, 2018 - September 30, 2018. **Payment will be due within 30 days from invoice date.**
2. Second payment with FY-19 funds will cover the remainder of SY 2018/2019:
  - a. October 1, 2018 - June, 2019. **Payment will be due within 30 days from invoice date.**

To qualify for the posted DoDEA Virtual High School (DVHS) tuition rate, students must be dependents of **active-duty service members**, have attended a DoDDS school or a Non-DoD School Program (NDSP) prior to returning to the United States, and **must** be enrolled in a local stateside school. The purpose of this tuition schedule is to provide an opportunity for students who transfer from an overseas location to a local stateside school in the United States to complete the course work that is not offered in the receiving school. Courses are only offered on a semester basis. All other instances will not qualify for this tuition rate.
