SUBJECT: DoDDS School Year (SY) 2015/2016 Tuition Rates

The tuition rates per the attached charts apply to Federally and Non-Federally connected, Non-Department of Defense students attending Department of Defense Dependents Schools during SY 2015/2016. It is DoDEA's policy, to collect payments in advance for a child who meets the enrollment criteria as a tuition paying student. The published rates include a non-refundable Treasury Share Fee. The Treasury Share Fee and the tuition rates are computed using the full cost recovery methodology in compliance with Government Accountability Office (GAO) guidelines.

Beginning SY 2015/2016, DoDEA is requiring sponsors to make two separate payments per school year based on the number of instructional days of the Fiscal Year (FY). The separate payments are required to accurately collect tuition during the FY in which the student attends school.

For example:

Federally Connected 9th grade student attending Bahrain HS tuition is \$24,648.00

FY 15 payment (# of instructional days from 1 Aug 15-30 Sep 15) Due August 31st: \$3,097.84

FY 16 payment (# of instructional days from 1 Oct 15-17 Jun 16) Due October 1st: \$21,550.16

To qualify for the posted DoDEA Virtual High School (DVHS) tuition rate, students must be dependents of active-duty service members, have attended a DoDDS school or Non-DoD School Program (NDSP) prior to returning to the United States, and must be enrolled in a local stateside school. The purpose of this tuition schedule is to provide an opportunity for students who transfer from an overseas location to a local stateside school in the United States, to complete coursework that is not offered in the receiving school. Courses are only offered on a semester basis. All other instances will not qualify for this tuition rate.
