SUBJECT: OCONUS School Year (SY) 2017/2018 Tuition Rates (Europe, Pacific, and Cuba):


The tuition rates per the attached charts apply to Federally and Non-Federally Connected, Non-Department of Defense students attending DoDEA Europe, Pacific, and Cuba schools during SY 2017/2018. It is DoDEA's policy to collect payment within 30 days from the tuition invoice date for a child who meets the enrollment criteria as a tuition paying student. Tuition is considered a debt to the Government; therefore, failure to pay tuition in a timely manner can result in the inability to enroll dependents at the beginning of the SY, or subsequent disenrollment during the SY. The published rates include a small **non-refundable Treasury Fee**. The Treasury Fee and the tuition rates are computed using the full cost recovery methodology in compliance with Government Accountability Office (GAO) guidelines

This year's tuition payment schedule dates will be based on the students sponsor's tuition enrollment category:

1. All Non-Federally Connected tuition payments will be made NLT: 30 days from the invoice date, **to cover the entire SY 17-18: August 2017 – June 2018** (Exceptions may apply). The tuition invoice will be sent during the first week of October, 2017.
2. Federally Connected tuition payments will be billed in **two partial payments**:
  - a. First payment with FY-17 funds will cover the First school Quarter: August, 2017 – November, 2017. **Payment due on or before July 31<sup>st</sup>, 2017.**
  - b. Second payment with FY-18 funds will cover the remainder of SY 17-18: November, 2017 – June, 2018. **Payment will be due within 30 days from the invoice date.**

To qualify for the posted DoDEA Virtual High School (DVHS) tuition rate, students must be dependents of **active-duty service members**, have attended a DoDDS school or a Non-DoD School Program (NDSP) prior to returning to the United States, and **must** be enrolled in a local stateside school. The purpose of this tuition schedule is to provide an opportunity for students who transfer from an overseas location to a local stateside school in the United States, to complete the course work that is not offered in the receiving school. Courses are only offered on a semester basis. All other instances will not qualify for this tuition rate..
