Situation	"School At Post" Education Allowance	"School Away from Post" Education Allowance	Home School Allowance
EVACUATION	<p>The "school at post" education allowance terminates when the child is evacuated to a safe haven in the U.S. without penalty to the employee given that U.S. public schools are an available option.</p> <p>However, if the school at the evacuated post offers a virtual/distance learning option, then expenses may continue while at the safe haven location (not to exceed the at post education allowance; not to exceed the end of school year even if evacuation continues)</p> <p>No education allowance at an alternate approved safe haven is authorized</p> <p>Special Education Allowances at an <b>Official</b> Foreign Safe haven maybe authorized (rare)</p> <p><i>DSSR 621.1(d)(1)&amp;2(d) &amp; 633.1, 633.2 and 633.3</i></p> <p>Contact the NDSP team with eligibility questions or special circumstances (i.e., high school seniors)</p> <p>Contact Information: <a href="mailto:ndsp.management@dodea.edu">ndsp.management@dodea.edu</a></p>	<p>The "school away from post" education allowance may continue until the end of the current school year during ordered/authorized departure.</p> <p>The "away from post" education allowance for the following school year is not authorized until the post's status is resolved and the evacuation terminates.</p> <p><i>DSSR 621.1(d)(2) &amp; 633.2</i></p> <p>Contact Information: <a href="mailto:ndsp.management@dodea.edu">ndsp.management@dodea.edu</a></p>	<p>The "home school" education allowance terminates when the child is evacuated to a safe haven in the U.S. without penalty to the employee given that U.S. public schools are an available option.</p> <p>The parent may opt to continue homeschooling, but may not be reimbursed fees incurred after the evacuation date.</p> <p>Contact Information: <a href="mailto:ndsp.management@dodea.edu">ndsp.management@dodea.edu</a></p>
